TERMS OF ENROLLMENT

- 1- Deposits are made and accepted as a mutually binding token and cannot be refunded after May 1. In the event of withdrawal prior to May 1, deposit is FULLY REFUNDABLE. The balance of the tuition is due by May 1. No refund can be made for non-arrival, late arrival or early departure, except as stated below.
- 2- The tuition rates include all regular camp activities, accommodations, and one camp shirt. Additional charges include canteen, elective programs such as horseback riding, and a camp store account for campers to purchase personal incidentals. Transportation to and from camp is the responsibility of the parent. More detailed information will be included with the enrollment information, or contact the office with any questions.
- 3- The director reserves the right to expel a camper, without refund, who in their discretion, has behaved in a manner contrary to the best interests of the camp. In the case of campers who, as a result of accident or illness incurred at camp, are absent from camp, arrangements will be made with the parent or guardian for prorated refund.
- 4- Parent consents to child taking supervised trips as part of summer program.
- 5- It is understood that all photography and videography taken by camp may be used for promotional purposes. This includes pictures on the website.
- 6- In the event that parent cannot be reached by phone, parent gives permission for medical professionals to administer emergency treatment to child.
- 7- Camp may terminate contract if tuition is not paid in full. Service will be suspended and deposit will not be refunded. 1½% per month late charge (after May 1st) will be added to past due accounts. In the event of delinquent payment, parent agrees to pay all legal fees (equal to the greater of \$300 or 1/3 of the delinquent amount plus interest) and costs incurred during collection process.
- 8- It is common for parents to request the addresses and phone numbers of campers in their child's cabin. Please check this box if you do not want this information to be given out .
- 9- This contract constitutes the full understanding of the parties hereto and no change, modification or waiver of any of the terms shall be effective unless in writing and signed by both parties. Any parent signing this agreement acknowledges that he/she is acting as agent of the non-signing parent, has the authority to enroll the child at camp and to execute this agreement on behalf of the non-signing parent. This contract is binding and any dispute between parents shall not affect the camp's right to enforce it.
- 10- It is agreed that the venue of trial of any dispute that may arise to which Greenwood Trails or its agents is a party, shall be in Nassau County, NY.
